The one-priority rule

Choose the service or question causing the most friction now. A focused comparison is easier to verify than a full household overhaul.

02

My first priority

Why it matters now:

Compare the decision, not the headline.

Use the same questions for every provider or option. Write down the source of every important claim.

Connectivity check

For internet, begin with the service address and the work, school, streaming, and device load. For mobile, begin with coverage, number of lines, device needs, and current plan terms.

Do not skip

Availability, eligibility, pricing, taxes, equipment, installation, cancellation, and provider terms can change. Verify them on the official page before ordering.

Evaluate an opportunity with clear eyes.

A presentation is information, not a commitment. Separate what was said from what you still need to verify.

Work

What activities are expected each week? What skills and time are realistically required?

02

Costs

What start-up and ongoing expenses apply? Which expenses are optional?

03

Customers

How are customers found and supported? What rules govern marketing and outreach?

04

Compensation

Where is the current official compensation information? What is not guaranteed?

05

Support

What training and team support are available, and who is responsible for each step?
